STUDENT ADMISSIONS POLICY 2022-2023

Age, Required Documents, School Hours, Tests, Uniform, Fees

| 1st Grade | Child must be 6 years old by December 31, 2022.Child must have successfully completed KG. Proof is required before enrollment. |
| 2nd to 8th Grades | Child must have successfully completed the previous grade. Proof is required before enrollment. |

REQUIRED DOCUMENTS: All documents must be presented at the time of registration. Also, children must have updated immunizations at the time of registration. No child is allowed to register without these documents.

1. Immunization Records:

- Children enrolling in Badr School for the first time must have a certificate of Immunization filled out and signed by a physician or Health Department Clinic.
- For students already attending Badr School, official documentation of updated immunization must be filed in the child’s record before or at registration. No students are allowed in the classroom without updated immunizations.

2. Proof of Medical Examination: State regulations require all children entering KG or 1st grade for the first time to have a complete medical examination within six months prior to the beginning of the school year.

3. Birth Certificate: A Birth Certificate is required for children enrolling in Badr school for the first time (translation is required if the Birth Certificate is not in English).

4. Social Security Card: The Social Security card is required for children enrolling in Badr School for the first time.

5. 2 Passport Photos: Every year 2 Passport photos must be presented at registration.

6. Proof of address: Every year a proof of address has to be presented at registration.

7. Any Separation between parents who have legal documentation to prove which parent has school right for the child/ren must be presented at the time of registration or after registration.

SCHOOL HOURS: School hours are 7:15 am to 2:50 pm. Parents must make sure their children arrive on time every morning between 7:15 and 7:30. Dismissal time is 2:50 pm sharp. Parents are required to pick up their children on time. A late pick up fee will be charged. All students are required to come to school on time. One absence is counted for every five lateness.

Additional conditions for new student registration:

- Transfer form and transcripts/report card from previous school. If applicable, please provide any ISP’S & IEP’S
- The student will be placed on an *academic and behavior probation* for three months, commencing from the first day the student is registered into Badr School.
- New students are required to take a placement test. If the student does not achieve a passing grade or low scores in Language Arts or Mathematics, the student will be placed in a program at Badr School.

TERMS OF AGREEMENT 2022-2023

1. Parents agree to abide by all school rules and regulations (not limited to those mentioned below).
 - a. Parents/guardians need to dress Islamically upon entering the school building.
 - b. Un-Islamic behavior by parents on school grounds or other will not be tolerated and may affect the enrollment of their child (expulsion)
 - c. Badr School reserves the right to deny registration or place conditions upon enrollment.
 - d. Badr School reserves the right to expel a student at any time (due to safety, behavior or academic reason, un-Islamic behavior and /or religious violations).
 - e. Parents/Guardians are responsible to notify the school principal of any custody restrictions and providing documentation. Parents are also responsible for notifying school principal in writing of any medical, health or psychological conditions or other.
 - f. The school reserves the right to not promote any student who does not meet school standards.
 - g. Students present in school building before or after school hours who are not officially enrolled in a program will be the responsibility of the parents/guardians.
 - h. Students who are picked up after dismissal time will be charged a fee of \$20.00 per 20 minutes.
 - i. Parents and student(s) are responsible for paying for any damaged or lost technological device, such as a tablet, computer, Chromebook, etc. Parents are responsible for paying for any lost or damaged textbooks.
 - j. Parents are responsible for paying for any damage done to school property by their child(ren)
 - k. Parents agree to give the school the right to photograph/videotape/record students for recreational/evaluation/educational purposes and publication thereof to include, but not limited to, the school's website.
 - l. Electronic devices must be turned in to school personnel upon arrival, otherwise, devices will be confiscated until further notice.
 - m. After school, weekend school and summer school require separate agreements.
2. **TUITION POLICY** (TUITION IS NON-REFUNDABLE, NON-TRANSFERABLE), tuition is a yearly fee broken down into semester or monthly payments to make payments easier for parents. Parents of registered students agree to pay the full yearly tuition fee even if the student withdraws, registers late, and /or graduates early.
 - a. Failure to maintain payments by the due dates indicated will result in child (ren) being dismissed from class and/or school.
 - b. Tuition is not refunded/transferred or accredited for suspensions, expulsions, or school closing.
 - c. Upon withdrawal from the school, all payments must be paid in cash or money order(NO CHECKS)
 - d. Child care programs are accepted. Parents are responsible to pay any co-payment and any outstanding balance in the event that the program has been cancelled for any reason.



TERMS OF AGREEMENT 2022-2023 (Continuation)

- a. School records and all official letters, including, but not limited to, report cards, transcript, etc. will be held until all accounts are paid in full.
- b. Returned/bounced check(s) due to insufficient funds will incur the charge of \$50.00. Post-dated checks will not be accepted.

g- WAITING LIST: Parents whose child (ren) is/are on a waiting list are responsible for the registration fee. If by the first week of school there is no room for the child in class, registration fees will be refunded. If the child is accepted, the parents are required to pay remaining fees. Failure to do so will result in the child losing his/her seat, and the registration fee will not be refunded. Registration fees will not be refunded if parent changes his/her mind. Waiting lists are on a first served basis-seats are limited.

h- Urban League

Any monthly tuition after financial aid is applied is solely the responsibility of the parents/guardians and are due at the end of the month. In the event of nonpayment, tuition payments are solely the responsibility of the parents/ guardians and are due immediately.
